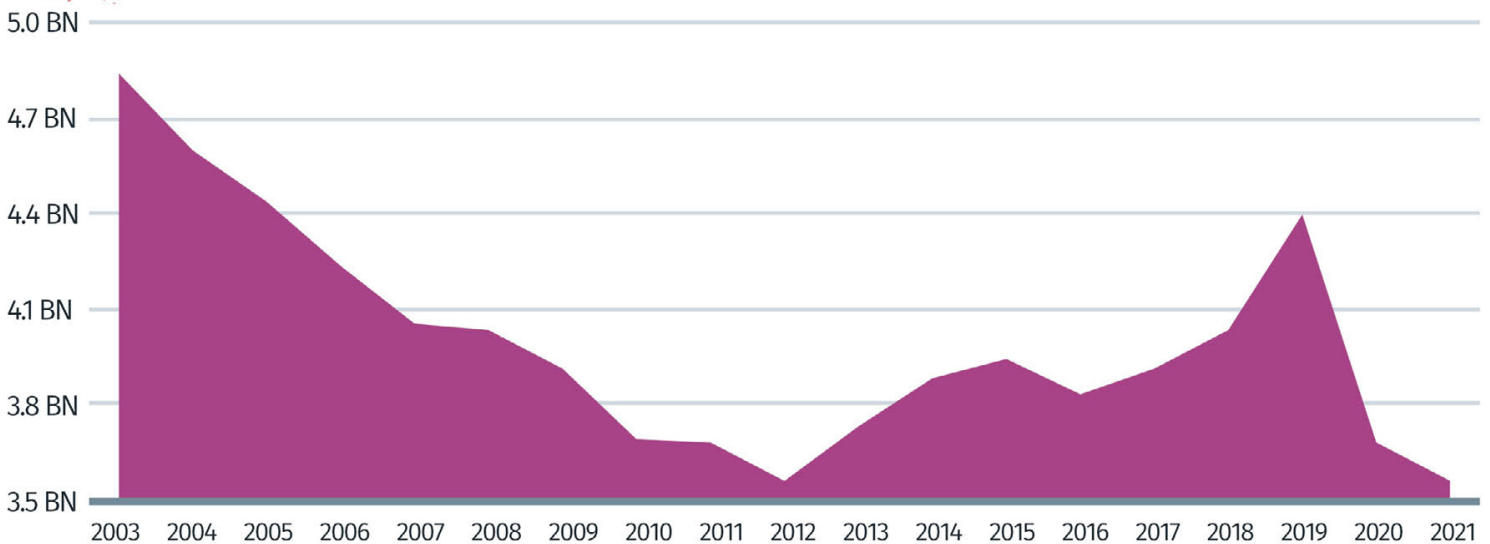

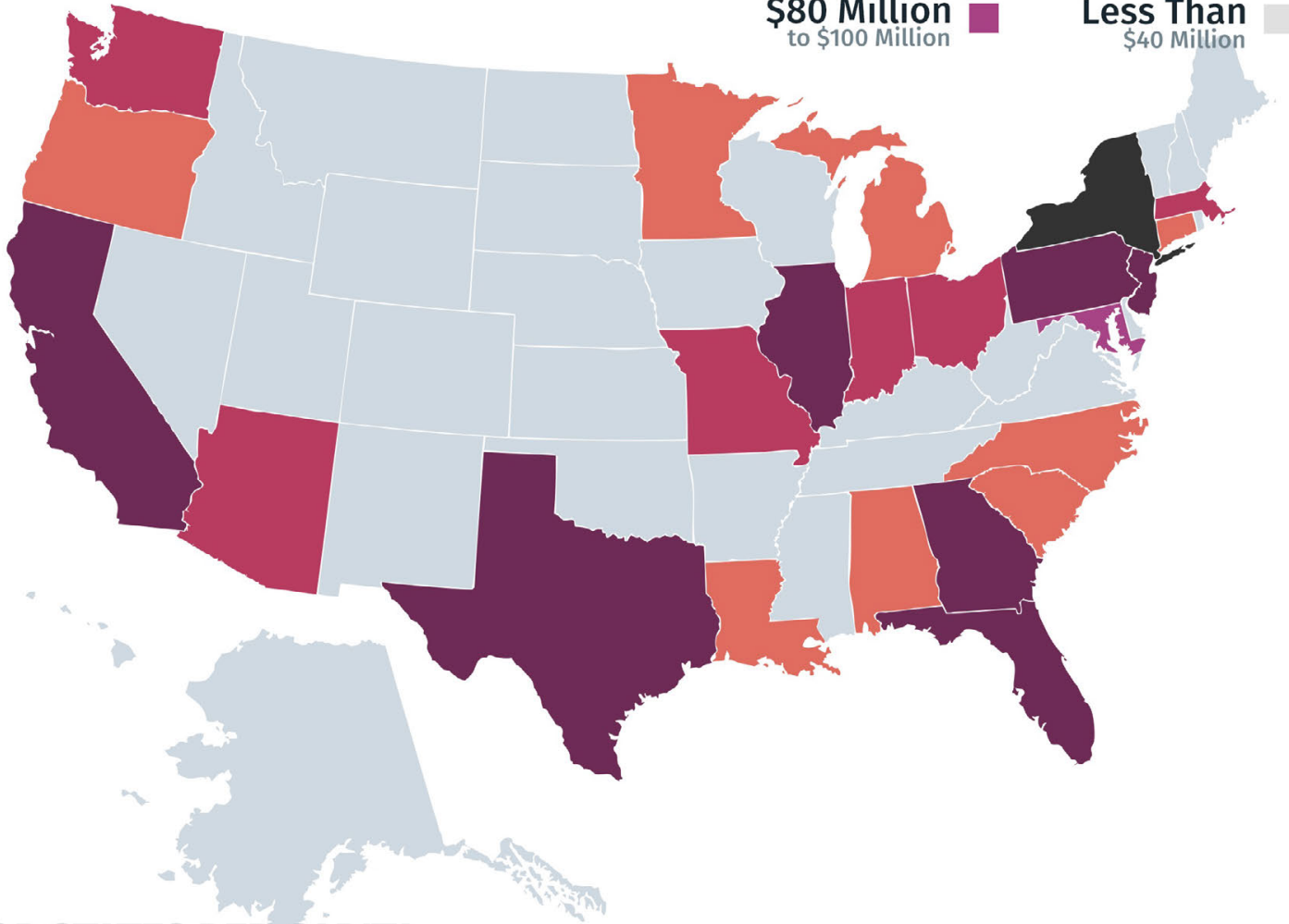

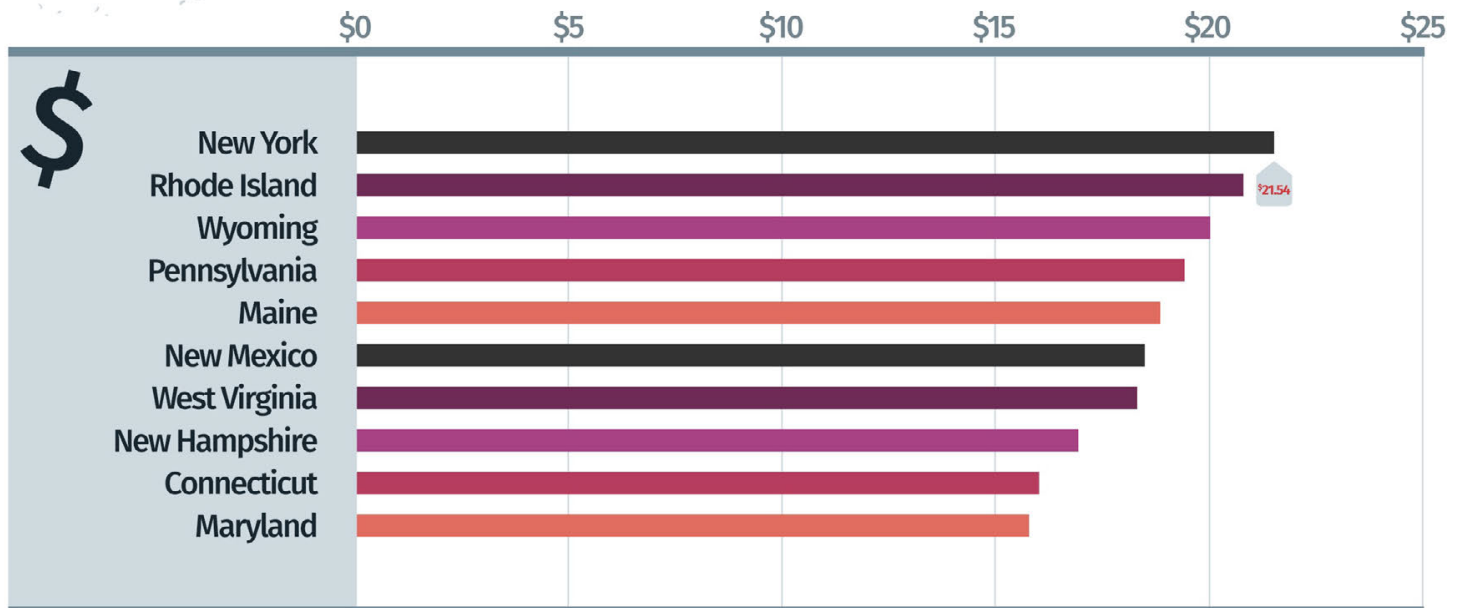
TOTAL PAYOUT AMOUNTS BY STATE

Payout amounts for the United States of America by the million in 2021.



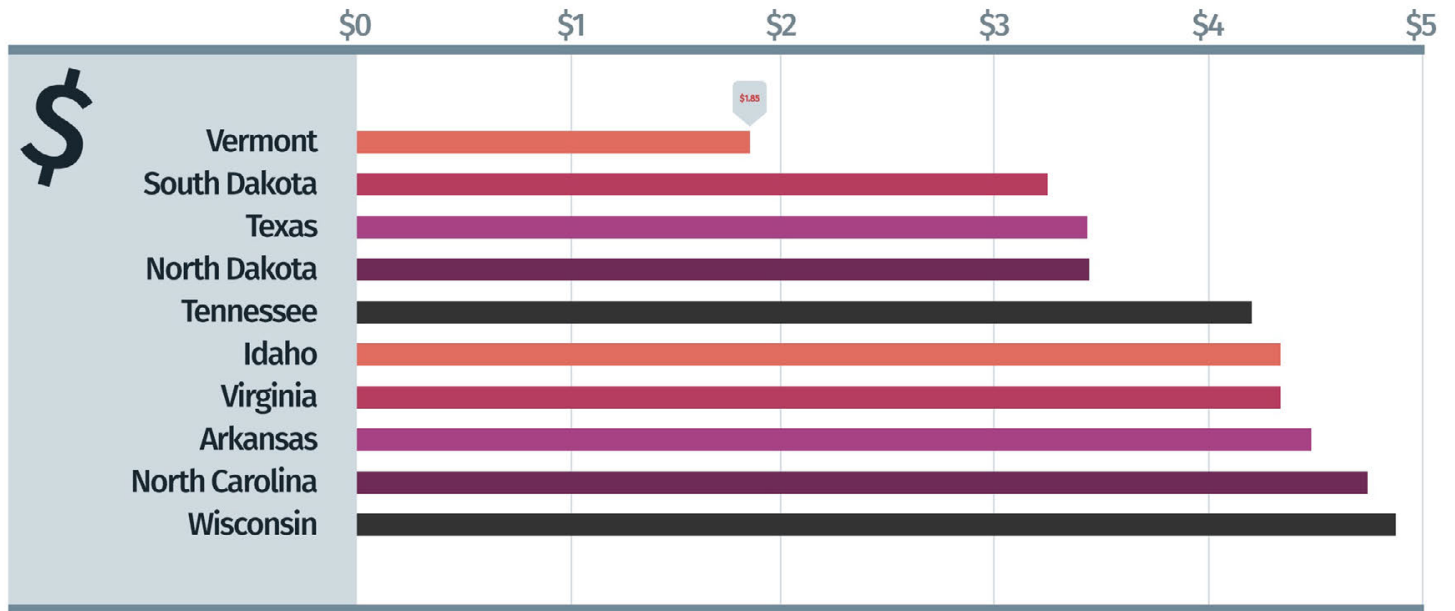
TOP STATES PER CAPITA

Total paid out per person residing in the state. Population estimates are taken from the US Census Bureau (see references).



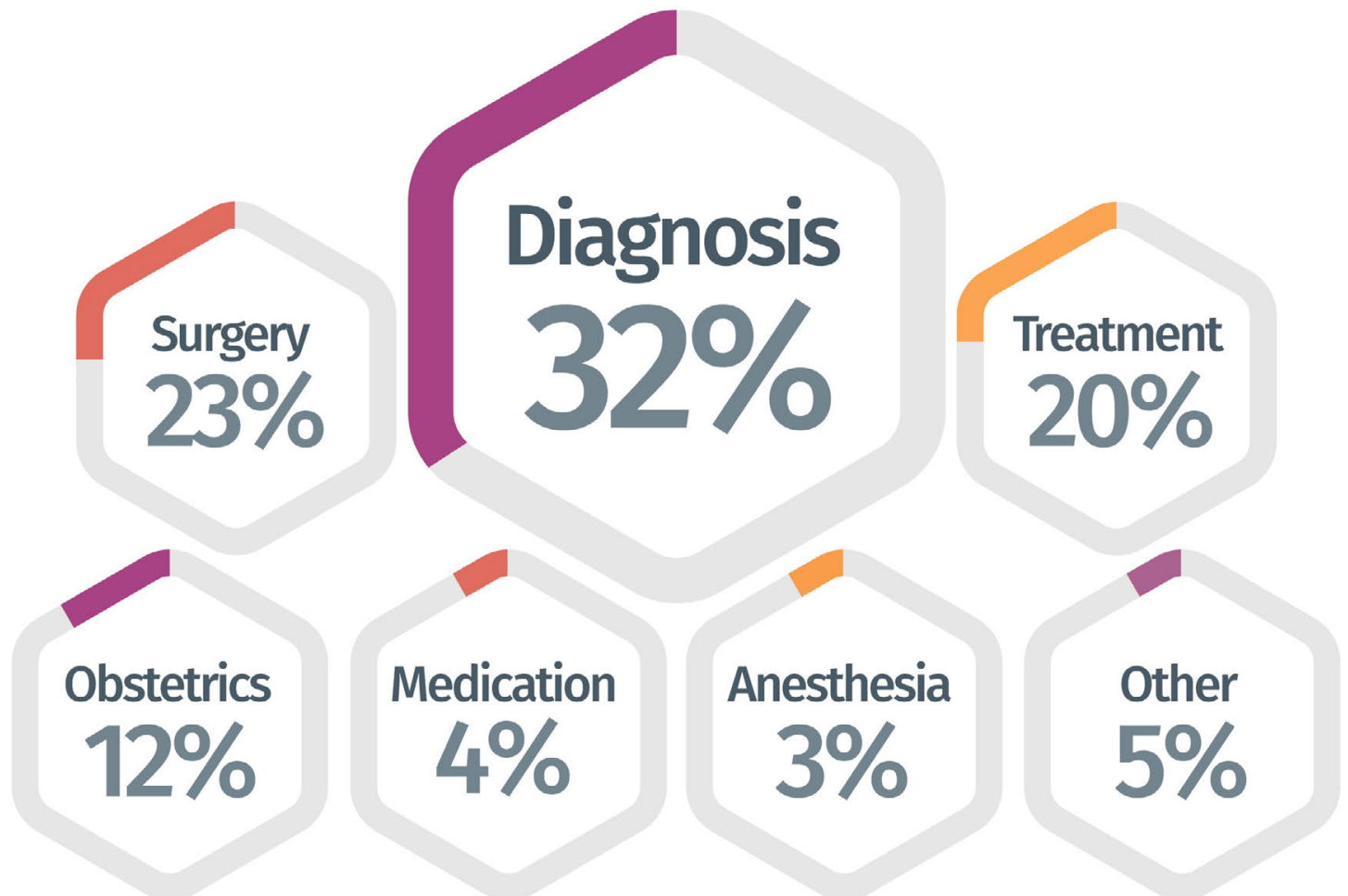
BOTTOM STATES PER CAPITA

Percentage of payment amounts by severity of the alleged outcome.



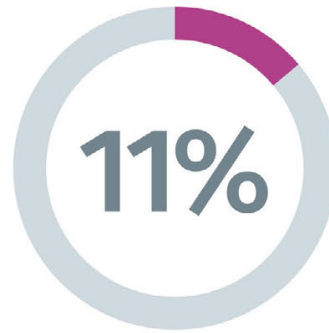

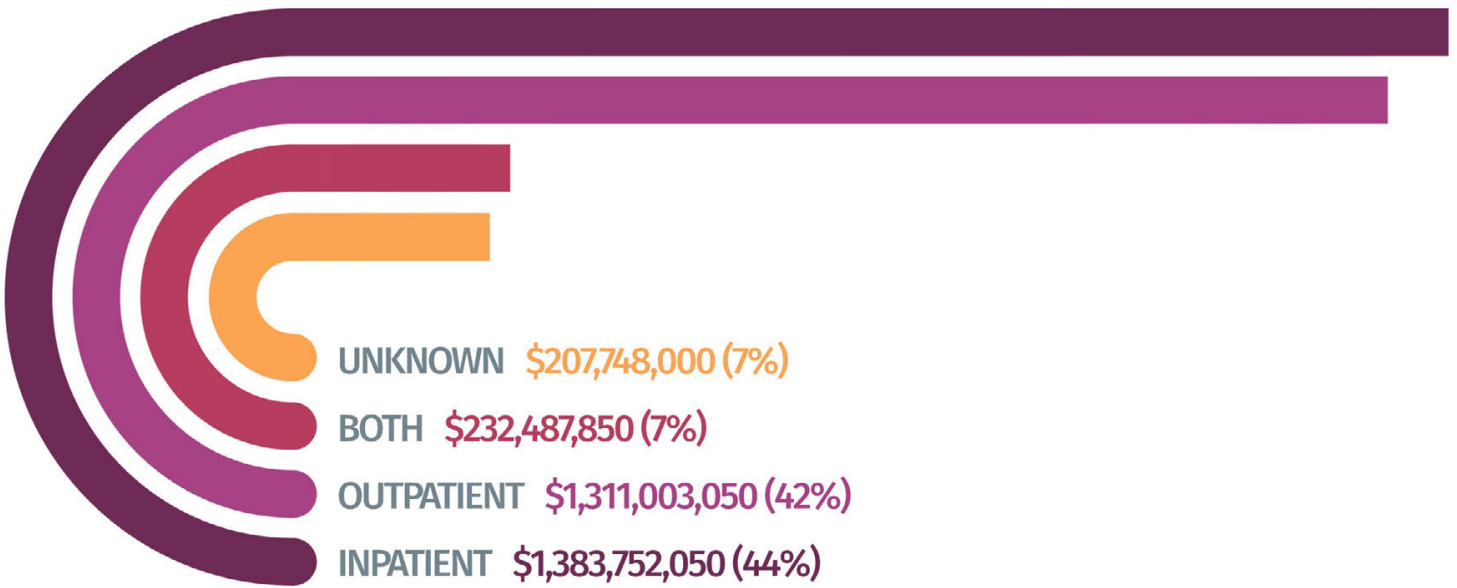

Total payment amount by patient type.



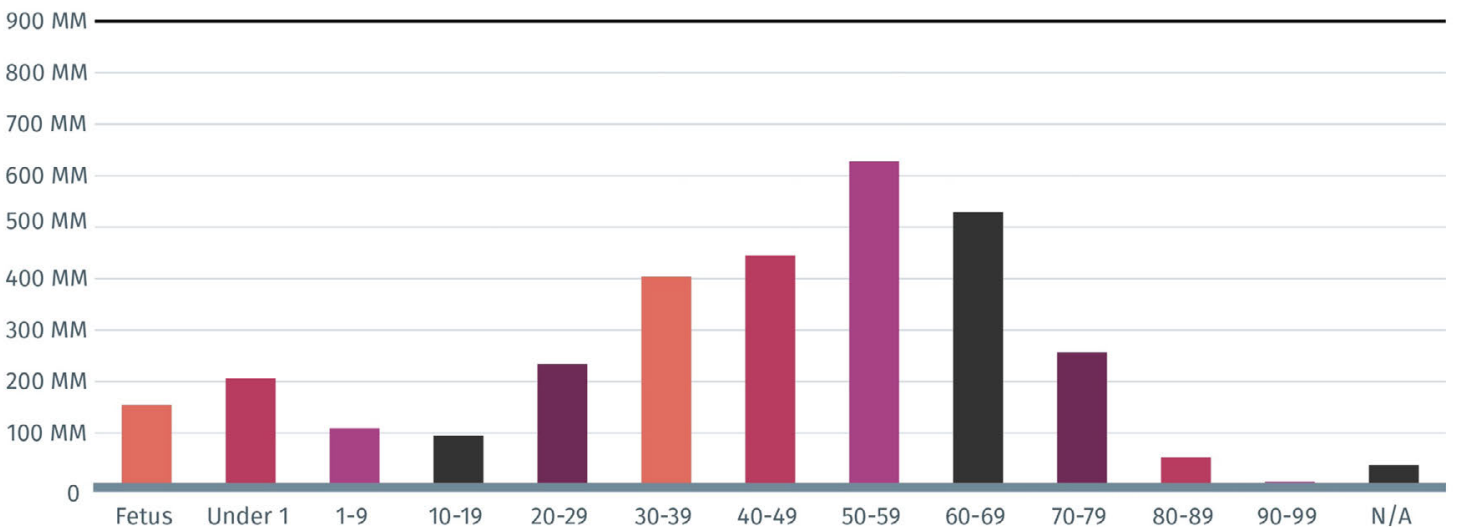
PATIENT GENDER

Percentage of total payment amount by patient gender.



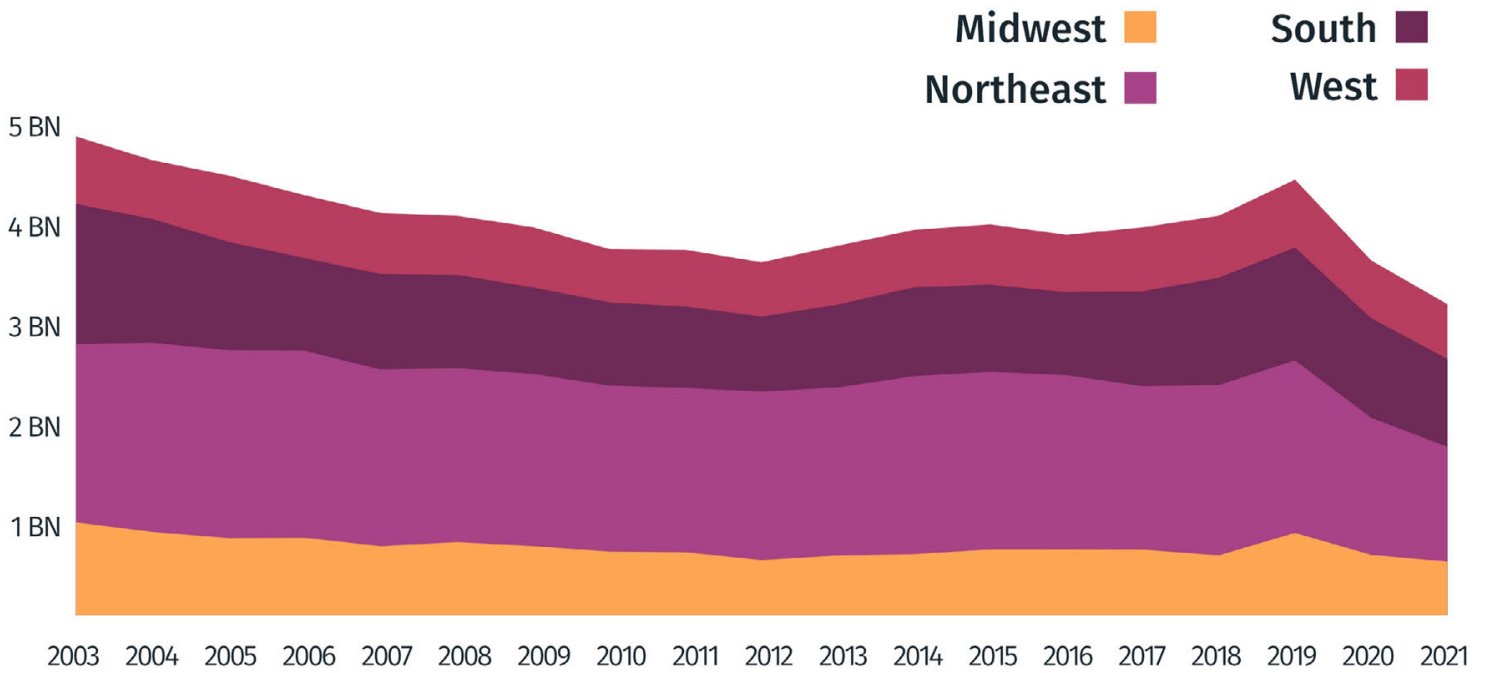
PATIENT AGE

Total payment amount by patient age. Payment amount (Y axis) is in millions of dollars.



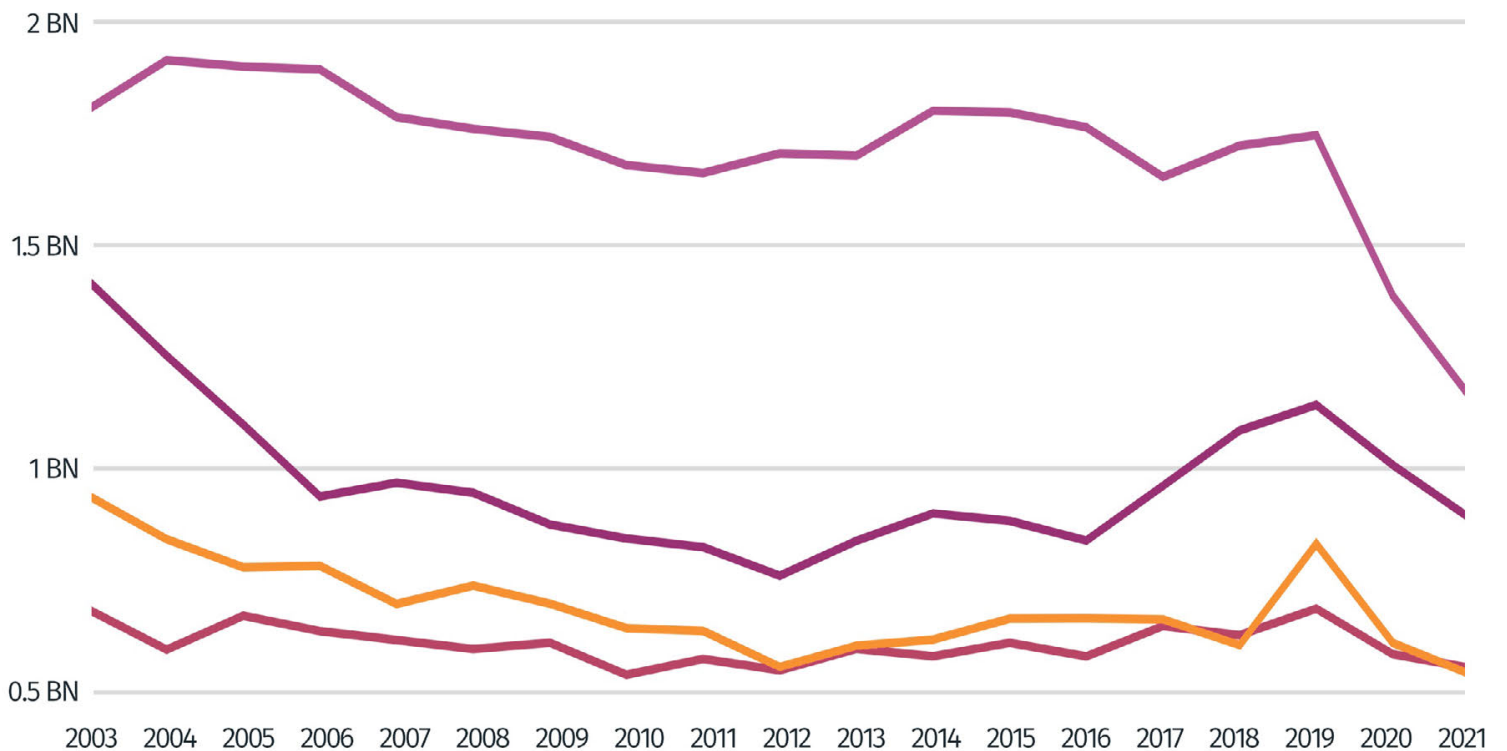
